ASSUMPTION OF RISK AND RELEASE OF ALL LIABILITIES, CLAIMS AND INJURIES

Please Read Carefully Before Signing

This Assumption of Risk and Release of all Liabilities, Claims and Injuries is required to be executed, at the sole discretion of Greenville Woodworkers Guild, Inc. (the "Guild") and its authorized agents, prior to participation in any activities on its premises known as Greenville Woodworkers Guild Education Center located at 209 Holly Ridge Court, Mauldin, South Carolina, 29662 (the "Premises"). These activities may include, but are not limited to, using woodworking tools, equipment and machinery located on the Premises.

I, _____, as the parent and/or legal guardian of a participant, as a condition to using the facilities at the Premises, agree to participate, or designate the below mentioned guardian appointed by me to participate, and allow the child named below, of whom I am a parent or legal guardian, to participate in the youth program activities at the Premises completely at my own risk.

I acknowledge that that the woodworking tools, equipment and machinery located on the Premises are dangerous. I represent and certify that I understand the risks involved in the use of such tools, equipment and machinery and in participating in woodworking activities on the Premises and am willing to assume full responsibility for myself and the child named below, of whom I am the parent or legal guardian, for expenses (including attorney fees and cost of litigation), loss of personal property, bodily injury and/or death arising out of, or in any way connected with, my participation and the participation of the child named below, of whom I am a parent or legal guardian, in activities on the Premises.

Without limiting the foregoing, I agree that the Guild or any other person associated with the Guild, including but not limited to their respective directors, officers, employees, volunteers and agents (the Guild, the Landlord and such other persons are referred to as the "Released Parties"), shall not be liable for any damages, including but not limited to those arising from personal injuries sustained by me or the child named below, of whom I am a parent or legal guardian in or about the Premises, whether or not caused by negligence of any of the Released Parties. This means that I assume all risks, known or unknown, involved in participation in any activity on the Premises and will hold the Released Parties harmless for any damages or injuries that I or the child named below, of whom I am a parent or legal guardian, may sustain in the pursuit of any activity while on or about the Premises. I assume full responsibility for any injuries or damages that may occur to me or the child named below, of whom I am a parent or legal guardian, in or about the Premises and fully and forever release and discharge the Released Parties from any and all claims, demands, rights or causes of action, whether present, future, known or unknown, anticipated or unanticipated, resulting from or arising out of my use or the use by the child named below, of whom I am a parent or legal guardian of the woodworking tools, equipment and machinery located on the Premises and/or in any other activities on the Premises.

I further agree to abide by and follow all applicable rules, policies and procedures of the Guild during my use of the facilities on the Premises and take full responsibility for the following of the same by the child named below, of whom I am the parent or legal guardian. I agree to immediately report any injuries or property damage or any condition that could be dangerous to others to a representative of the Guild who is present on the Premises.

I HAVE READ AND UNDERSTAND THIS ASSUMPTION OF RISK AND RELEASE OF ALL LIABILITIES, CLAIMS AND INJURIES. I AM UNDER NO INDUCEMENT TO SIGN AND REALIZE THAT BY DOING SO, I GIVE UP SUBSTANTIAL RIGHTS ON BEHALF OF MYSELF AND THE CHILD NAMED BELOW, OF WHOM I AM A PARENT OR LEGAL GUARDIAN.
